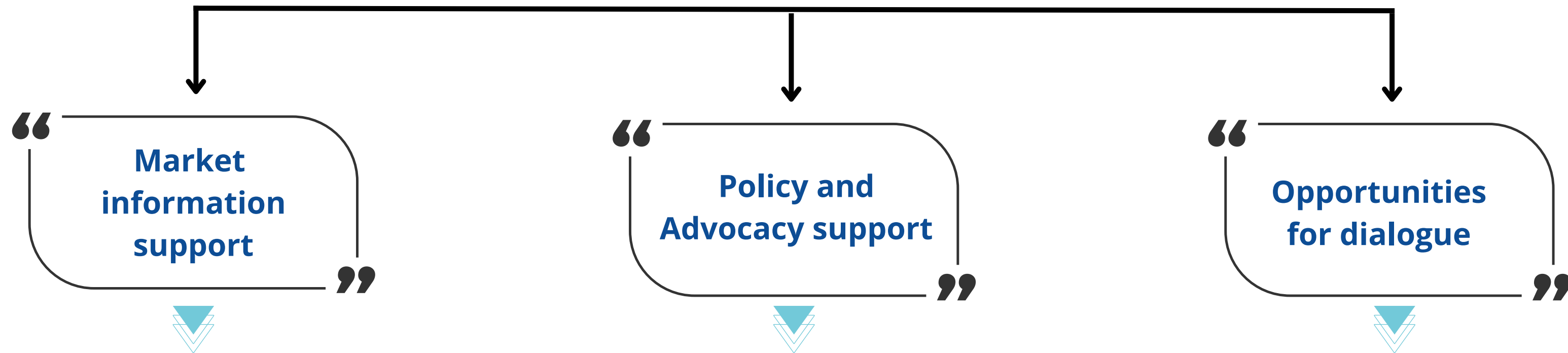

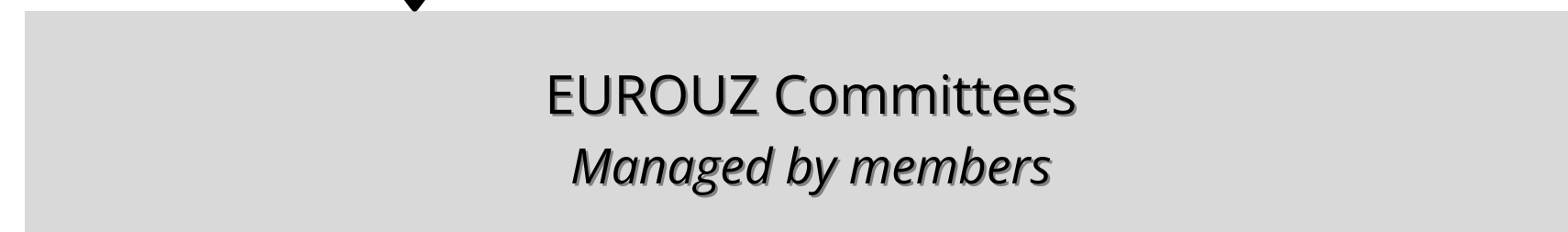

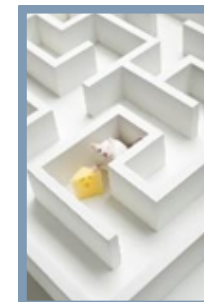
How do we manage engagement?

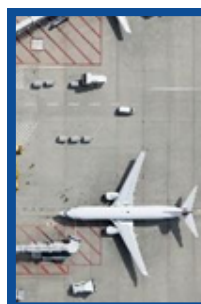
